CATEGORIES OF MEMBERS

Members shall be divided into the following categories:

Honorary Life Members

Adherent Members

Full Members

Associates Members

A. Honorary Life Members

The Executive Committee may with the approval of the Society in General Meeting elect any person who is considered to have rendered some special service to the Society for election as a Honorary Life Member of the Society.

B. Full Members

Any Chief Concierge (having 2 years of experience of being a Chief Concierge of a hotel in Hong Kong) or Assistant Chief Concierge (having 3 years of experience of being an Assistant Chief Concierge of a hotel in Hong Kong) who also acquired a minimum of 5 years working experience in the Concierge Department of a hotel may apply for election as full member of the Society. A reference letter from his/her hotel General Manager is required to be submitted to the Executive Committee upon application.

C. Adherent Members

Any Chief Concierge or Assistant Concierge (who having 2 years of experience of being a Chief Concierge or Assistant Concierge of a hotel in Hong Kong but less than 5 years working experience in the Concierge Department of a hotel in Hong Kong) may apply for election as adherent member of the Society. A reference letter from his/her hotel General Manager is required to be submitted to the Executive Committee upon application.

D. Associate Members

The Executive Committee may, with the approval of the Society in General Meeting, elect any person, firm or company who is deemed to possess the appropriate qualifications from election as an Associate Member of the Society. All persons, firms or companies that apply to become Associate Members should have at least three years successful track record in their business or field.
